**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AN AGREEMENT WITH THE FIL-CHI LOVE AND CARE FOUNDATION, INCORPORATED, AND CARLOS O. COJUANGCO (COC) FOUNDATION FOR THE MOBILE DIGITAL OPPORTUNITY PROGRAM**

**WHEREAS**, one of the priority concerns of the government is to improve the quality of life of the young people through the provision of productive opportunities for them and the enhancement of their employability;

**WHEREAS**, it is the aim of the LOCAL GOVERNMENT OF PURA; FIL-CHI LOVE AND CARE FOUNDATION, INC.; and CARLOS O COJUANGCO (COC Foundation) to cooperate with each other to provide free basic computer training for unemployed adults, out of school youth and other constituents of Pura under the MOBILE DIGITAL OPPORTUNITY PROGRAM;

**WHEREAS**, after a detailed examination of the provisions of a draft Memorandum of Agreement of the above mentioned parties, the Sangguniang Bayan find it be proper and beneficial to the constituents of the municipality, most especially the youth;

**NOW THEREFORE**, on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby RESOLVED to AUTHORIZE the MUNICIPAL MAYOR to enter into an agreement with the FIL-CHI LOVE AND CARE FOUNDATION, INCORPORATED, and CARLOS O. COJUANGCO (COC) FOUNDATION in providing free basic computer training in the municipality under the MOBILE DIGITAL OPPORTUNITY PROGRAM;
