A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE PURA MUNICIPAL POLICE STATION; THE *LIGA NG MGA BARANGAY*, REPRESENTED BY ITS PRESIDENT, HON. EDILBERTO D. TABAQUIN JR.; AND THE NATIONAL POLICE COMMISSION REGIONAL OFFICE NO. 3, FOR THE COMMUNITY AND SERVICE-ORIENTED POLICING (CSOP)

WHEREAS, the National Police Commission (NAPOLCOM), in line with Section 2, of Republic Act No. 8551, otherwise known as “*The PNP Reform and Reorganization Act of 1998*” instituted Community and Service-Oriented Policing as the foundation and backbone of community-oriented policing and crime prevention on the country;

WHEREAS, the Department of Interior and Local Government (DILG) is pushing for the strengthening of the Peace and Order Councils (POCs) of LGUs through the adoption of Peace and Order and Safety (POPS) Planning, a methodical process that will develop a plan responsive to the local criminality and other security and public safety issues and supportive of the LGUs Comprehensive Development Plan;

WHEREAS, Section 64 of Republic Act No. 8551, likewise, provides that the Governors and Mayors, having been duly elected and having qualified as such, are automatically “deputized as representatives of NAPOLCOM in their respective jurisdiction”;

WHEREAS, the Local Chief Executive of Pura, the Municipal Police Station, and the Pura ABC President, have agreed on entering into partnership in several undertakings to effectively strengthen the peace and order and public and safety and justice delivery mechanism in the municipality;

WHEREAS, the said proponents furnished the Sanggunian a draft copy of their Memorandum of Agreement for its review and the Sanggunian deems it proper and lawful;

NOW THEREFORE, upon the motion of Councilor Freddie D. Domingo, Chairman of Committee on Peace and Order and Public Safety, duly seconded by Councilor John Paul M. Balmores, Chairman of the Committee on Rules, Privileges and Legal Matters, it is hereby **RESOLVED** to **AUTHORIZE** the Local Chief Executive to enter into an Agreement with the Pura Municipal Police Station; the Liga ng Mga Barangay, represented by its President, Hon. Edilberto D. Tabaquin Jr.; and the National Police Commission Regional Office No. 3, for the Community and Service-Oriented Policing (CSOP);

RESOLVED FURTHER, to furnish copy of this resolution to all persons and agencies who may be concerned and/or affected by virtue hereof.
