**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AN AGREEMENT FOR WORK IMMERSION PARTNERSHIP WITH THE MAUNGIB HIGH SCHOOL IN CONNECTION WITH THE IMPLEMENTATION OF THE SENIOR HIGH SCHOOL PROGRAM OF THE DEPARTMENT OF EDUCATION (DepEd)**

WHEREAS, the Department of Education (DepEd) of the Philippines, is the primary government instrumentality mandated to formulate, implement, and coordinate policies, plans, programs and projects in the areas of formal and non-formal basic education; supervise all elementary and secondary education institutions, including alternative learning systems, both public and private; and provide for the establishment and maintenance of a complete, adequate, and integrated system of basic education relevant to the goals of national development;

WHEREAS, the DepEd has introduced the K to 12 basic education reform that includes Senior High School (SHS), with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning;

WHEREAS, the SHS curriculum can be customized at the local levels to take into consideration the needs of local industries and the labor market;

WHEREAS, the DepEd believes that for the effective delivery of SHS instructions, there is a need for school-industry partnership that will provide the school the necessary expertise and venue for practical, on-the-job, enterprise-based training for SHS learners;

WHEREAS, the DepEd started full implementation of SHS in School Year 2016-2017;

WHEREAS, the MAUNGIB HIGH SCHOOL (MHS) is among those that will offer SHS to students in the community to carry out DepEd’s objectives for SHS as spelled out above;

WHEREAS, to achieve this objective, the MHS needs to enter into a Work Immersion partnership with this Local Government Unit (LGU);

WHEREAS, this Local Government Unit (LGU) operates in the area where the School is located and has offices, facilities, project sites, and expertise that it can make available to the School for purposes of student work immersion;

WHEREAS, the LGU considers going into a work immersion partnership with the MHS as part of its mission to create a positive impact on the community, especially the young people;

WHEREAS, the institutionalization and implementation of the K to 12 program is among the priority programs of the Government for promoting inclusive growth;

WHEREAS, the LGU is encouraged to fully support the successful implantation of the K to 12 Program of the Department of Education as stated in Paragraph 4, Section 2 of the Republic Act 9155 or “Governance of Basic Education Act of 2001”;

WHEREAS, the LGU recognizes the need for a work immersion environment that is safe for the student and teachers, and conducive to learning, and the capability to provide these;

WHEREAS, the MHS and the LGU, hereinafter collectively referred to as “PARTIES”, undertake to collaborate towards the successful implementation of the Senior High School in the Barangay/Municipality/City/Province cognizant of the need for special protection of the child and with the best interest of the SHS learner at heart;

NOW, THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor to enter into an Agreement with the Maungib High School in connection with the foregoing premises, subject to ratification by this Sangguniang Bayan.

RESOLVED FURTHER, to furnish copy of this resolution to all agencies concerned for their information and appropriate action.
