A RESOLUTION SUPPORTING THE FAMILY DEVELOPMENT SESSION (FDS) AND RECOGNIZING THE MUNICIPAL FAMILY DEVELOPMENT SESSION TEAM FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM (4P's) OF THE MUNICIPALITY

WHEREAS, the Pantawid Pamilya National Advisory Committee (NAC) is the highest policy-making inter-agency body that provides policy directions and guidance on matters pertinent to program implementation;

WHEREAS, Administrative Order No. 16, Series of 2008, entitled Guidelines on the Implementation of Pantawid Pamilyang Pilipino Program, provides cash grant to extremely poor households to address their immediate consumption needs, while the conditionalities are focused on building human capital and, thus, breaking the intergenerational cycle of poverty;

WHEREAS, one of the program conditionalities which are bases for providing grants to the household grantees is their attendance to the Family Development Sessions (FDS);

WHEREAS, the FDS aims to enhance and acquire new skills and knowledge of household grantees and parents in responding to their parental roles and responsibilities particularly on the health and nutrition, education, protection and psychosocial needs of children; promote positive family values; strengthen marital relationships; and promote involvement, participation, volunteerism, and leadership and active citizenship for strengthened community empowerment;

WHEREAS, inviting Resource Persons from other agencies/institutions at the local setting to become FDS implementers is a constant practice on the ground which is institutionalized in the Pantawid Pamilyang Pilipino Program Memorandum Circular No. 02, Series of 2003, entitled Guidelines on the Implementation of Family Development Sessions (FDS) in the Pantawid Pamilyang Pilipino Program;

WHEREAS, to ensure that monthly FDS is observed by the parent grantees, the state of the Municipality Family Development Session Team was organized with the following composition, to wit:
