RESOLUTION REQUESTING THE SANGGUNIANG PANLALAWIGAN TO ALLOW THE WITHDRAWAL OF THE SUBMITTED PROPOSED ANNUAL BUDGET OF THE MUNICIPALITY OF PURA FOR THE C.Y. 2020 TO ALLOW INTRODUCTION OF ADJUSTMENTS TO CONFORM TO THE PARAMETERS PRESCRIBED BY EXISTING LAWS

WHEREAS, the Municipality of Pura submitted before the Sangguniang Panlalawigan, for its mandatory review, Appropriation Ordinance No. 004, Series of 2019, otherwise known as the Annual Budget of the Municipality of Pura for the C.Y. 2020;

WHEREAS, subsequently, the Municipality of Pura, discovered discrepancies in the proposed budget which were inadvertently overlooked during its review phase;

WHEREAS, there is necessity to withdraw the submitted Proposed Annual Budget to rectify the said discrepancies and to conform to the parameters prescribed by law;
