RESOLUTION NO. 023

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE METRO CLARK WASTE MANAGEMENT CORPORATION

WHEREAS, the Metro Clark Waste Management Corporation manages and operates a sanitary landfill, built and operated accordance with Republic Act No. 9003, at the Clark Integrated Waste Management Center located at Sub-zone D, Clark Special Economic Zone, as permitted with Environmental Compliance Certificate No. 0012-704-213, and TSD Facility Registration # TR 03-69-0002;

WHEREAS, this Local Government Unit is generating, recycling and hauling residual municipal solid waste for disposal and is looking for a sanitary landfill facility as final disposal for such residual municipal solid waste;

WHEREAS, Section 22, paragraph (c), of Republic Act No. 7160, otherwise known as the “*Local Government Code of 1991*”, provides in part that, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization from the Sanggunian concerned;

WHEREAS, likewise, Section 444, paragraph (b) (1) (vi), of the same Code provides that for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall, exercise general supervision and control over all programs, projects, services and activities of the municipal government and in this connection, shall upon authorization by the Sangguniang Bayan, represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

NOWHEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to authorize the Local Chief Executive to enter into an agreement, for and on behalf of this Local Government Unit, with the Metro Clark Waste Management Corporation;
