RESOLUTION NO. 029

A RESOLUTION AUTHORIZING THE CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA), OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), DEPARTMENT OF LABOR-REGION III, AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA), WITH RESPECT TO THE PROMOTION OF THE RIGHTS AND WELFARE OF THE PUBLIC MIGRANT WORKERS AND THEIR FAMILIES

WHEREAS, the government has continuously strengthened its information campaign on its national policies, and programs and services for the public and migrant workers, specifically on welfare services, anti-illegal recruitment and the anti-trafficking in persons, skills training, reintegration, and public information and education;

WHEREAS, the convergence of programs by the DOLE is a strategy to enhance the empowerment and protection of the public and migrant workers and to optimize the limited resources of government;

WHEREAS, the law mandates local government units, in partnership with the concerned government agencies, to take proactive stance in disseminating information to their constituents on all aspects of overseas employment;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby RESOLVED to AUTHORIZE the Chief Executive to enter into an agreement with the Philippine Overseas Employment Administration (POEA), Overseas Workers Welfare Administration (OWWA), Department of Labor-Region III, and Technical Education and Skills Development Authority (TESDA), with respect to the promotion of the rights and welfare of the public migrant workers and their families.

RESOLVED FURTHER, to furnish copies of this resolution to all persons and entities concerned.
