A RESOLUTION RESPECTFULLY REQUESTING FROM CONGRESSMAN JOSEPH STEPHEN S. PADUANO OF THE ABANG-LINGKOD PARTYLIST, TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF PURA FOR THE CONSTRUCTION OF A TWO-STOREY SCHOOL BUILDING IN BARANGAY BALITE, PURA, TARLAC

WHEREAS, the Municipality of Pura was heavily hit by an earthquake in 1990, damaging major infrastructures including government buildings, houses and school buildings;

WHEREAS, in 1991, some school buildings were replaced and some were only repaired and after almost 30 years, many of the school buildings are now beyond repair and dilapidated;

WHEREAS, our building officials declared some buildings in Doña Felisa Y. Sawit Elementary School, located in Barangay Balite, Pura, Tarlac as unsafe and condemned;

WHEREAS, due to the meager resources of the Local Government Unit of Pura, there is a need to request from external sources for the construction of much needed school building;

NOW THEREFORE, upon unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to adopt a resolution respectfully requesting from CONGRESSMAN JOSEPH STEPHEN S. PADUANO of the Abang-Lingkod Party-list, to Extend Financial Assistance to the Municipality of Pura, for the Construction of a Two-Storey School Building in Barangay Balite, Pura, Tarlac.
