RESOLUTION NO. 049

Series of 2020

A RESOLUTION AUTHORIZING THE UTILIZATION OF 2019 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) FUND, AMOUNTING TO ONE MILLION FIVE HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED TEN PESOS AND SIXTY FOUR CENTAVOS (P 1,518,510.64) FOR THE PROVISION OF RELIEF ASSISTANCE TO FAMILIES AFFECTED BY THE COVID-19 CRISIS

WHEREAS, President Rodrigo Roa Duterte, through Proclamation No. 929, placed the entire Philippines under *State of Calamity* due to the Corona Virus Disease 2019 (COVID-19) Pandemic;

WHEREAS, due to the magnitude of the effect of the said crisis, the thirty percent (30%) *Quick Response Fund* is not enough to provide assistance to the families greatly affected;

WHEREAS, the municipality has savings from its 2019 LDRRM Fund which formed part of the LGU Trust Fund Account;

WHEREAS, the municipality sought to utilize the said savings to augment the aforementioned *Quick Response Fund* for the provision of relief assistance;


NOW THEREFORE, on unanimous motion presented, it is hereby RESOLVED to AUTHORIZE the utilization of 2019 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) FUND, amounting to **ONE MILLION FIVE HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED TEN PESOS AND SIXTY FOUR CENTAVOS (P 1,518,510.64)** for the provision of relief assistance to families affected by the COVID-19 Pandemic;
