**A RESOLUTION REALIGNING THE AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) FROM THE CURRENT YEAR'S 20% DEVELOPMENT FUND TO BE UTILIZED FOR COVID-19 RELATED EXPENSES**

WHEREAS, Republic Act No. 11469, otherwise known as the “*Bayanihan to Heal as One Act*”, permitted the Local Government Units to amend its Annual Investment Fund and to re-align portion of the 20% of its Development Fund for COVID-19 related expenses;

WHEREAS, the municipality has appropriated the following amount under its Development Fund:

Completion of the LGU Activity Center	<b>P 4,000,000.00</b>
Establishment of Small Water Impounding Facility at <i>Susubaen</i> Creek	<b>P 1,000,000.00</b>


WHEREAS, the Municipality sought to realign the aforementioned amount to augment existing fund for COVID-19 related expenses;

NOW THEREFORE, on unanimous motion presented, it is hereby RESOLVED to AUTHORIZE REALIGNMENT of the amount of FIVE MILLION PESOS (P5,000,000.00) from the Current Year's 20% Development Fund to be utilized for Covid-19 Related Expenses;
