**A RESOLUTION AUTHORIZING THE LOCAL CHIEF TO ENTER INTO AN AGREEMENT, FOR AND IN BEHALF OF THE MUNICIPALITY, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE-III RELATIVE TO (1) FUND TRANSFER AND FACILITATION OF DISTRIBUTION OF DSWD'S PROGRAMS AND SERVICES IN CONNECTION TO THE CURRENT EMERGENCY CRISIS BROUGHT ABOUT BY THE CORONAVIRUS DISEASE (COVID-19) PANDEMIC; AND (2) NON-DISCLOSURE AND CONFIDENTIALITY AGREEMENT**

WHEREAS, the declaration of Enhanced Community Quarantine and the corresponding imposition of Stringent Social Distancing Measures to alleviate the spread of Coronavirus Disease (COVID-19) affected DSWD's social contacts and conduct of assemblies like payouts for beneficiaries of certain government projects and programs;

WHEREAS, the Local Government Units are partners of the National Government Agencies in the implementation of its services and programs;

WHEREAS, fund transfer to LGUs is identified as a mode of payment to fast track the facilitation of the distribution of DSWD programs and an interim solution for the current emergency crisis;

NOW THEREFORE, on unanimous motion, it is hereby RESOLVED to AUTHORIZE the Local Chief Executive to enter into an agreement, for and in behalf of the municipality, with the DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE-III relative to (1) Fund transfer and facilitation of distribution of DSWD's programs and services in connection to the current emergency brought about by the Coronavirus Disease (COVID-19) Pandemic; and (2) Non-disclosure and confidentiality Agreement.
