A RESOLUTION REALIGNING THE 20% ECONOMIC DEVELOPMENT FUND (EDF) APPROPRIATED TO VARIOUS PROGRAMS AMOUNTING TO ONE MILLION EIGHT HUNDRED THOUSAND PESOS (P 1,800,000.00)

WHEREAS, the municipality has appropriated 20% Economic Development Fund (EDF) from its budget for the FY 2020 for the (a) Provision of Sanitation and Hygiene Facilities; and (b) COVID-19 Related Expenses;

WHEREAS, the municipality recognizes the lack of fund to finance the unanticipated but essential purchase/program:

1. Purchase of four (4) sets sand separator/filter bag housing for existing Pura Water Stations at Barangays Singat; Nilasin 2nd; and Poblacion 3

WHEREAS, there is a necessity to realign the 20% Economic Development Fund for it to be utilized for the purchase and program mentioned above;

NOW THEREFORE, the matter having been certified as urgent by the Local Chief Executive and on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby **RESOLVED to AUTHORIZE the REALIGNMENT** of the portion of the 20% Development Fund for FY 2019 appropriated for various programs, amounting to a total of **ONE MILLION EIGHT HUNDRED THOUSAND PESOS (P 1,800,000.00)** for the Purchase of four (4) sets sand separator/filter bag housing for existing Pura Water Stations at Barangays Singat; Nilasin 2nd; and Poblacion 3.
