RESOLUTION NO. 081

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGION III, RELATIVE TO THE IMPLEMENTATION OF THE HOME CARE SUPPORT SERVICES FOR SENIOR CITIZENS IN THE MUNICIPALITY

WHEREAS, the Department of Social Welfare and Development (DSWD) developed the project, entitled “**Home Care Support Services for Senior Citizens (HCSSC)**” to address issues concerning the simultaneous rapid growth in senior citizen population and the increase in their special needs particularly the sickly, frail, bedridden, neglected and abandoned senior citizens through a community-based strategy which aims to promote protection of older persons against any form of abuse by involving the senior citizens, their families, neighborhood and communities to take effective steps to care for senior citizens, foster healthy and harmonious familial relationship between the senior citizens and their family or kinship carers;

WHEREAS, the Local Government Unit (LGU), with the DSWD envision that the older persons particularly the sickly, frail, bedridden, neglected and abandoned senior citizens in the community will have reduced vulnerabilities to physical and mental abuse, be treated fairly, live in dignity and security, be free from exploitation and benefit from family and community care through increased access to quality response and reintegration of services and participation in preventive actions through the **Home Care Support Services for Senior Citizens**;

WHEREAS, it is the desire of the LGU of Pura to improve assistance to older persons particularly the sickly, frail, bedridden, neglected and abandoned senior citizens, and strengthen the concept of social responsibility among community members;

WHEREAS, Section 444, paragraph (b) (1) (vi), of the Local Government Code of 1991 provides that for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall, exercise general supervision and control over all programs, projects, services and activities of the municipal government and in this connection, shall upon authorization by the sangguniang bayan, represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

NOW THEREFORE, upon unanimous motion presented, be it:

RESOLVED, as it is hereby resolved to AUTHORIZE the Local Chief Executive to enter into an Agreement with the DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGION III, Relative to the Implementation of the HOME CARE SUPPORT SERVICES FOR SENIOR CITIZENS in the Municipality.

RESOLVED FURTHER, that copies of this resolution be respectfully forwarded to the Local Chief Executive and the Department of Social Welfare and Development Field Office III for their information and guidance.
