RESOLUTION NO. 082

Series of 2020

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF TARLAC FOR THE ISSUANCE OF COVID PERSONAL PROTECTIVE EQUIPMENTS (PPEs)

WHEREAS, President Rodrigo Roa Duterte, issued Proclamation Nos. 922 and 929 has declared a state of Public Health Emergency and State of Calamity, respectively, throughout the Philippines due to Coronavirus Disease 2019 (COVID-19);

WHEREAS, the said Presidential Proclamations provides that “all government agencies and local government units (LGUs) are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in timely manner to curtail and eliminate the CoVID-19 threat” and prevent serious disruption of the functioning of the government and community;

WHEREAS, Section 3 of Republic Act No. 11469, otherwise known as the “*Bayanihan to Heal as One Act*” provides that there is an urgent need to mitigate if not contain, the transmission of COVID-19, undertake measures that will prevent overburdening of healthcare system, and promote and protect the collective interest of all Filipinos in these challenging times;

WHEREAS, the surge of COVID-19 cases worldwide resulted to critical supply shortage of key equipment needed to care for patients such as Personal Protective Equipment (PPE) among hospitals in city and other municipalities of Tarlac Province including health care institutions;

WHEREAS, there is an urgent need for the Local Government Unit of Pura to secure PPEs for its LGU, but limited capacity to do so in a timely manner due to lack of immediately available supplies;

WHEREAS, the Provincial Government of Tarlac undertakes to render necessary support and assistance to the LGU of Pura in response to its urgent need to procure key equipment to eliminate and contain COVID-19 in the Province of Tarlac;

NOW THEREFORE, upon unanimous motion presented, be it:

RESOLVED, as it is hereby resolved to AUTHORIZE the Local Chief Executive to enter into an Agreement with the PROVINCIAL GOVERNMENT OF TARLAC for the Issuance of COVID PERSONAL PROTECTIVE EQUIPMENTS (PPEs).

RESOLVED FURTHER, to furnish copy of this resolution to all agencies concerned for their information and appropriate action.
