A RESOLUTION REALIGNING THE 20% DEVELOPMENT FUND (DF) APPROPRIATED TO VARIOUS PROGRAMS AMOUNTING TO ONE MILLION PESOS (P 1,000,000.00)

WHEREAS, the municipality has appropriated 20% Development Fund (DF) from its budget for the FY 2020 for the (a) Expansion of Water System at Sitio Kabayugan, Nilasin 2nd; and (b) Concreting of FMR at Barangay Poblacion No. 1;

WHEREAS, the municipality recognizes the lack of fund to finance the unanticipated but essential projects/programs:

Concreting of Local Access Road at Sitio Kabayugan, Nilasin 2 nd ; and	P 500,000.00
Backfilling of Fishpond at the back of the Pura Central Elementary and High School.	P 500,000.00

WHEREAS, there is a necessity to realign the 20% Development Fund for it to be utilized for the programs mentioned above;

NOW THEREFORE, the matter having been certified as urgent by the Local Chief Executive and on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby **RESOLVED to AUTHORIZE the REALIGNMENT** of the portion of the 20% Development Fund for FY 2020 appropriated for various programs, amounting to a total of **ONE MILLION PESOS (P 1,000,000.00)** for the (a) *Concreting of Local Access Road at Sitio Kabayugan, Nilasin 2nd*; (b) *Backfilling of Fishpond at the back of the Pura Central Elementary and High School*;


RESOLVED FURTHER, to furnish copy of this resolution to persons and agencies concerned.
