**A RESOLUTION REALIGNING THE 5% GENDER AND DEVELOPMENT (GAD) FUND APPROPRIATED TO VARIOUS PROGRAMS AMOUNTING TO NINE HUNDRED ONE THOUSAND PESOS (P 901,000.00)**

WHEREAS, the municipality has appropriated 5% Gender and Development (GAD) Fund from its budget for the FY 2020 for the following projects/programs:

1. Municipal Centralized Feeding Program;
2. Conduct of summer sports clinic and reading camp for the youth;
3. GAD Database updating and management;
4. Conduct of Socio-Cultural Activities such as Panagyaman Festival and Harvest Festival;
5. Conduct of case finding through Chest X-ray and sputum exam;
6. Conduct of World TB Day and Lung Month;
7. Women's right/VAWC Activities;
8. Provision of Community Fitness Activities;
9. Continuous involvement of LGU key personnel in GAD related workshops and writeshops;
10. Provision of livelihood programs for Solo parents ;
11. SME's entrepreneurial training in partnership with DTI and DOLE; and
12. Continuous marketing, research and development and Promotional Activities of LGU products.

WHEREAS, the municipality recognizes the lack of fund to finance the unanticipated but essential projects/programs:
