A RESOLUTION REALIGNING THE AMOUNT OF ONE MILLION TWO HUNDRED TWENTY THOUSAND EIGHT HUNDRED FIFTY ONE PESOS AND 23/100 (P 1,220,851.23) FROM SAVINGS IN THE PERSONAL SERVICES OF VARIOUS OFFICES OF THE LGU FOR THE GRANT OF PERFORMANCE-BASED BONUS TO QUALIFIED MUNICIPAL GOVERNMENT PERSONNEL FOR FY 2019

WHEREAS, Executive Order (EO) No. 201, series of 2016, provides that the compensation and position classification shall be revised or updated to strengthen the performance-based incentive system in recognition of government personnel who play a greater role and carry a heavier responsibility in attaining performance targets and delivering results;

WHEREAS, the DILG-DBM issued Joint Memorandum Circular No. 2019-1, prescribing the criteria and condition for the grant of the Performance-Based Bonus to qualified local government personnel for the FY 2019;

WHEREAS, to be able to grant the Performance-Based Bonus to qualified personnel of this LGU, there is a necessity to realign funds from available sources;

WHEREAS, the Statement of Supplemental Appropriation submitted by the Municipal Budget Officer indicates that the amount of **ONE MILLION TWO HUNDRED TWENTY THOUSAND EIGHT HUNDRED FIFTY ONE PESOS AND 23/100 (P 1,220,851.23)** is now available for realignment;

NOW THEREFORE, on motion of Councilor John Paul M. Balmores, duly seconded, be it:
