**A RESOLUTION APPROVING BARANGAY MATINDEG APPROPRIATION ORDINANCE NO. 03, SERIES OF 2020, INVOLVING AN AMOUNT OF SEVEN HUNDRED FIFTY SEVEN THOUSAND TWO HUNDRED NINETY PESOS AND 63/100 (P 757,290.63); AND RESOLUTION NO. 01, SERIES OF 2020, REALIGNING THE UNUTILIZED BUDGET FROM THE 10% SK FUND 2020 AMOUNTING TO NINETY FIVE THOUSAND PESOS (P 95,000.00) TO FINANCE AND AUGMENT THE VARIOUS EXPENSES OF SANGGUNIANG KABATAAN**
