A RESOLUTION APPROVING BARANGAY POROC RESOLUTION NO. 07, SERIES OF 2020, INVOLVING AN AMOUNT OF TWENTY FIVE THOUSAND PESOS (P 25,000.00); AND RESOLUTION NO. 08, SERIES OF 2020, INVOLVING AN AMOUNT OF NINETY EIGHT THOUSAND THREE HUNDRED FIFTEEN AND 10/100 (P 98,315.10), REALIGNING THE UNUTILIZED BUDGET FROM THE 10% SK FUND 2020 TO FINANCE PRIORITY PROJECTS OF THE BARANGAY

WHEREAS, Barangay Poroc submitted for review copies of (a) RESOLUTION NO. 07, SERIES OF 2020, involving an amount of Twenty Five Thousand Pesos (P 25,000.00); and (b) RESOLUTION NO. 08, SERIES OF 2020, involving the amount of Ninety Eight Thousand Three Hundred Fifteen and 10/100 (P 98,315.10), both Realigning the Unutilized Budget from the 10% SK Fund 2020 to Finance the Priority Projects of the Barangay;
