RESOLUTION NO. 104

Series of 2020

A RESOLUTION APPROVING THE REALIGNMENT OF CURRENT YEAR’S 20% DEVELOPMENT FUND AMOUNTING TO THREE MILLION ONE HUNDRED TWENTY FIVE THOUSAND PESOS (P 3,125,000.00) AND CURRENT 5% GENDER AND DEVELOPMENT FUND AMOUNTING TO SEVEN HUNDRED THOUSAND PESOS (P 700,000.00) FOR THE IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS OF THE MUNICIPALITY

WHEREAS, the Municipal Development Council passed its Resolution No. 3, Series of 2020, realigning the Current Year’s 20% Development Fund Amounting to Three Million One Hundred Twenty Five Thousand Pesos (P 3,125,000.00) and Current 5% Gender and Development Fund Amounting to Seven Hundred Thousand Pesos (P 700,000.00);

WHEREAS, the Municipality has included in the 2020 Development Fund and GAD Fund the PPA’s under the priority developments trust of the LGU;

WHEREAS, the municipality recognizes the lack of fund to finance the following unanticipated but essential PPA’s:

Extension of Roofing for the Pura Public Market (Vegetable Section)	450,000.00
Procurement of Emergency Vehicle for Brgy. Maasin and Poblacion No. 1	2,175,000.00
Additional Appropriation for the Procurement of Garbage Compactor	500,000.00
5% GAD Fund	
Provision of Canopy at the RHU waiting area	700,000.00
TOTAL	3,825,000.00

WHEREAS, there is a necessity to realign the 20% Development Fund and 5% GAD mentioned above for it to be utilized for the PPA's mentioned in the next preceding paragraph;

NOW THEREFORE, the matter having been certified as urgent by the Local Chief Executive and on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby **RESOLVED to AUTHORIZE the REALIGNMENT** of Current Year's 20% Development Fund Amounting to Three Million One Hundred Twenty Five Thousand Pesos (P 3,125,000.00) and Current 5% Gender and Development Fund Amounting to Seven Hundred Thousand Pesos (P 700,000.00) for the Implementation of Various Programs and Projects of the Municipality.
