A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO PURCHASE, IN BEHALF OF THE MUNICIPALITY, PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 52137, LOCATED AT BARANGAY POBLACION NO. 1, PURA, TARLAC, OWNED AND REGISTERED IN THE NAME OF FRANCISCA ESTAVILLO, MARRIED TO BARTOLOME BALA

WHEREAS, as part of the priority projects of the municipality, it plans to establish an extension of the Municipal Cemetery, and as such, there is a necessity to acquire lot as site in connection thereto;

WHEREAS, the properties of Francisca Estavillo, married to Bartolome Bala, located Barangay Poblacion No. 1, Pura, Tarlac, covered by Transfer Certificate of Title No. 52137, was considered by the municipality to be the most feasible site for the aforementioned project;

WHEREAS, the fund to be utilized for the said projects including the fund for the purchase of the lot are sourced from the 20% Economic Development Fund (EDF) of the Municipality;
