RESOLUTION NO. 106

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE LGU SHARE ON CHARITY FUND AND CALAMITY ASSISTANCE PROGRAM

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency mandated to raise and provide funds for health programs, medical assistance and services, and charities of national character, through the conduct of sweepstakes, races, nationwide online lottery (“Lotto”), Small Town Lotery (STL) and other similar activities;

WHEREAS, the trust of the administration of President Rodrigo Roa Duterte are to ensure the provision and availability of medical facilities for emergency services, health care programs and social services, and provide appropriate forms of assistance to areas and persons affected by calamities and disasters;

WHEREAS, the PCSO recognizes the role of LGUs as PCSO’s partnership in raising revenues within their jurisdiction and in turn would like to support LGUs in providing the needed medical and health services to their constituents;

WHEREAS, pursuant to its mandate and aligned with the President’s programs, the PCSO provides LGU with a portion of the charity fund generated from the sales of Lotto and STL within their jurisdiction, as share for LGU to be used for their medical and health-related services;

WHEREAS, the PCSO also provides Calamity Assistance to the LGU in times of natural calamities and disasters, including those caused by outbreaks, epidemics and pandemics;

NOW THEREFORE, on unanimous motion presented, it is hereby **RESOLVED** to AUTHORIZE the Local Chief Executive to enter into an agreement with the PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) for the LGU Share on Charity Fund and Calamity Assistance Program;

RESOLVED FURTHER, to furnish copy of this resolution to COLONEL ROYINA MARZAN GARMA, General Manager, Philippine Charity Sweepstakes Office (PCSO), Mandaluyong City, for her information and appropriate action.
