A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGION III (DOLE-REGION III) FOR THE ESTABLISHMENT OF LIVELIHOOD PROJECT ENTITLED “COMMUNITY ENTERPRISE DEVELOPMENT PROGRAM FOR THE LIVELIHOOD ENHANCEMENT OF THE FEDERATION OF SENIOR CITIZENS, INC.” OF PURA, TARLAC
