A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY REGION III (DOST-III) FOR THE ESTABLISHMENT OF FOOD SUPPLEMENT PROCESSING CENTER FOR FSCAP-PURA CHAPTER

WHEREAS, the LGU-PURA has submitted a proposal to DOST-III through the Provincial Science and Technology Center-Tarlac (PSTC-TARLAC) that seek assistance in the upgrading the processing facility of the Federation of Senior Citizens Association of the Philippines (FSCAP PURA CHAPTER) with S&T Technologies the production of products from turmeric and malunggay;
