**A RESOLUTION APPROVING THE REALIGNMENT OF 20% ECONOMIC DEVELOPMENT FUND (EDF) AMOUNTING TO THREE MILLION SIXTY-ONE THOUSAND FIVE HUNDRED SIXTY-NINE PESOS AND 23/100 (P 3,061,569.23) AND 5% GENDER AND DEVELOPMENT (GAD) FUND AMOUNTING TO ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P 135,000.00) FOR THE IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS OF THE MUNICIPALITY**

WHEREAS, the municipality has appropriated 20% Development Fund from its budget for the FY 2020 for the (a) Procurement of Lot for the Municipal Cemetery; (b) COVID Related Expenses; (c) Concreting of FMR's of Barangays Balite and Naya; (c) Support Fund to Palay Seed Grower; and (d) Development of LGU Techno Demo Farm;

WHEREAS, the municipality has likewise appropriated 5% Gender and Development (GAD) from its budget for the FY 2020 for the (a) PhilHealth Enrollment Assistance to indigent Puranian's in need of medical assistance; (b) Provision of financial/medical assistance for VAW C victims; and (c) Provision of counseling and psycho-social services for VAW C victims;

WHEREAS, the municipality recognizes the lack of fund to finance the following unanticipated but essential purchases/programs:

WHEREAS, there is a necessity to realign the 20% Economic Development Fund and 5% Gender and Development Fund mentioned above for it to be utilized for the purchases and programs mentioned in the next preceding paragraph;

Balmores, duly seconded, it is hereby **RESOLVED to AUTHORIZE the REALIGNMENT** of 20% Economic Development Fund (EDF) Amounting to **THREE MILLION SIXTY-ONE THOUSAND FIVE HUNDRED SIXTY-NINE PESOS AND 23/100 (P 3,061,569.23)** and 5% Gender and Development (GAD) Fund Amounting to **ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P 135,000.00)** for the Implementation of Various Programs and Projects of the Municipality
