A RESOLUTION APPROVING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY FOR FISCAL YEAR 2021

WHEREAS, Section 354 of Republic Act No. 7160, otherwise known as “*The Local Government Code of 1991*”, provides that the Secretary of Budget and Management and the Chairman of the Commission on Audit (COA) shall jointly promulgate a Budget Operations Manual for Local Government Units to improve and systematize methods, techniques, and procedures employed in budget preparation, authorization, execution and accountability;

WHEREAS, Article 410 of the Implementing Guidelines of RA 7160 provides that the Local Development Council shall submit to the Local Finance Committee a copy of the Local Development Plan and Annual Investment Plan prepared and approved during the fiscal year in accordance with applicable laws, specifying therein the projects proposed for inclusion in the local government budget;

WHEREAS, the Annual Investment Plan has already been reviewed by the Sangguniang Bayan and found to have substantially complied with the general standards and guidelines set forth by law;

NOW, THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to approve the 2021 Annual Investment Plan (AIP) of the municipality.
