A RESOLUTION APPROVING BARANGAY LINAO APPROPRIATION ORDINANCE NO. 04, SERIES OF 2020, INVOLVING AN AMOUNT OF ONE HUNDRED THREE THOUSAND FOUR HUNDRED FIFTY FIVE PESOS AND 58/100 (P 103,455.58); AND RESOLUTION NO. 23, SERIES OF 2020, REALIGNING THE ALLOCATED BUDGET FROM THE 10% SK FUND 2020 AMOUNTING TO NINETY FIVE THOUSAND PESOS (P 95,000.00) FOR THE PRIORITY PROJECTS OF THE BARANGAY

WHEREAS, Barangay Linao submitted for review a copy of its APPROPRIATION ORDINANCE NO. 04, SERIES OF 2020, authorizing Supplemental Budget No. 04, Series of 2020, involving an amount of One Hundred Three Thousand Four Hundred Fifty Five Pesos and 58/100 (P 103,455.58); and RESOLUTION NO. 23, SERIES OF 2020, Realigning the Appropriated Budget from the 10% SK Fund 2020 Amounting to Ninety Five Thousand Pesos (P 95,000.00) for the Priority Projects of the Barangay;
