**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT FOR THE GRANT OF COVID-19 ACTIVE HAZARD DUTY PAY (AHDP) AND SPECIAL RISK ALLOWANCE (SRA) TO QUALIFIED PUBLIC HEALTH WORKERS AND OTHER PERSONNEL RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE 2019**

**WHEREAS**, Republic Act No. 11494, otherwise known as the “*Bayanihan to Recover as One Act*”, and Administrative Order Nos. 35 and 36, both dated November 16, 2020, signed by President Rodrigo Roa Duterte, on the grant of Active Hazard Pay (AHDP) and Special Risk Allowance (SRA) to all qualified frontliners directly catering to COVID-19 patients for every month of service rendered;

**WHEREAS**, the LGU-PURA shall be directly responsible and accountable for the grant and disburse of AHDP and SRA to qualified public health workers, subject to the conditions provided for in the aforementioned guidelines and under Joint Circular Nos. 1 and 2, both dated November 25, 2020, issued by the DBM and the DOH;

**NOW THEREFORE**, on motion by Councilor John Paul M. Balmores, duly seconded, IT IS HEREBY RESOLVED to AUTHORIZE the Municipal Mayor to enter into an agreement with the DEPARTMENT OF HEALTH (DOH) CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT FOR THE GRANT OF ACTIVE HAZARD DUTY PAY (AHDP) AND SPECIAL RISK ALLOWANCE (SRA) TO QUALIFIED PUBLIC HEALTH WORKERS AND OTHER PERSONNEL RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE 2019;
