**A RESOLUTION RESPECTFULLY REQUESTING FINANCIAL ASSISTANCE FROM HON. WENDELL ELIOT AVISADO, SECRETARY OF DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), IN THE AMOUNT OF TWENTY MILLION PESOS (P 20,000,000.00) CHARGEABLE AGAINST THE LOCAL GOVERNMENT SUPPORT FUND-OTHER FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS AS PROVIDED FOR UNDER THE CY 2021 GENERAL APPROPRIATIONS ACT (GAA), FOR THE BARANGAY INFORMATION SYSTEM (BIS) AND INSTALLATION OF BARANGAY CCTVs WITH MUNICIPAL COMMAND CENTER**

WHEREAS, the Local Government Unit of Pura has identified the need to implement the Barangay Information System (BIS) in all of its sixteen (16) barangays;

WHEREAS, there is also the need to install CCTVs in all barangays for ease of monitoring in times of calamities and as a means of crime prevention;

WHEREAS, under DILG Memorandum Circular No. 2020-117, dated September 4, 2020, all barangays are required to establish the Barangay Profile System (BPS) module under the BIS;

WHEREAS, the Local Government Unit of Pura lacks necessary funds to implement the above-stated projects;

NOW THEREFORE, upon unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to adopt a resolution respectfully requesting from **HON. WENDEL ELIOT AVISADO, SECRETARY OF DEPARTMENT OF THE BUDGET AND MANAGEMENT (DBM)**, in the Amount of Twenty Million Pesos (P 20,000,000,00) chargeable against the Local Government Support Fund-Other Financial Assistance to Local Government Units as provided for under the CY 2021 General Appropriations Act (GAA), for the Barangay Information System (BIS) and Installation of Barangay CCTVs with Municipal Command Center.
