**A RESOLUTION FERVENTLY REQUESTING HONORABLE SECRETARY WENDEL E. AVISADO, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO EXTEND FINANCIAL ASSISTANCE FOR THE PROCUREMENT OF ONE THOUSAND THREE HUNDRED THIRTY (1,330) UNITS OF TABLETS AMOUNTING TO TEN MILLION PESOS (10,000,000.00) TO BE DISTRIBUTED TO THE QUALIFIED UNDER PRIVILEGED STUDENTS IN THE MUNICIPALITY OF PURA**

WHEREAS, the biggest challenge for schools transition to online learning is the undeniable inequality of access to and use of information and communication technology;

WHEREAS, a great number of students from the municipality belong to the poorest and underprivileged family who do not have the financial capacity to purchase for themselves gadgets and other learning paraphernalia necessary to cope with the present system, particularly online classes;

WHEREAS, by reason of the lack of financial capacity, aggravated by the present situation brought about by the pandemic, the Local Government of Pura would not be able to achieve its advocacy of providing aide to the youth for their academic endeavors;

NOW THEREFORE, on unanimous motion, it is hereby RESOLVED to manifest most respectfully the fervent request to honorable **SECRETARY WENDEL E. AVISADO, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)** to extend financial assistance for the procurement of one thousand three hundred thirty (1,330) units of tablets amounting to **TEN MILLION PESOS (10,000,000.00)** to be distributed to the qualified under privileged students in the MUNICIPALITY OF PURA.

RESOLVED FURTHER, to issue copy of this resolution to the Honorable Secretary of the DBM and to all concerned persons and agencies.
