Justification for the UNUTILIZED FUND

The funds appropriated in the 5% GAD PB for 2018 was not fully utilized due to some factors;

- 1) Seminar/Workshops/Orientation activities were conducted simutaneously to fully maximize the LGU resources.
- 2) PPAs that are lodged in some departments were fully implemented without spending the budget appropriated in the GAD PB.
