**AN ORDER REESTABLISHING THE GENDER AND DEVELOPMENT
MONITORING AND EVALUATION TEAM OF THE MUNICIPALITY OF PURA,
TARLAC**

WHEREAS, Philippine Commission on Women (PCW), Department of the Interior and Local Government, Department of Budget and Management, and National Economic and Development Authority Joint Memorandum Circular (JMC) No. 2013-01, as amended, entitled, “Guidelines on the Localization of the Magna Carta of Women” provides that all Local Government Units (LGUs) shall create and maintain a gender responsive Monitoring and Evaluation (M&E) System;

WHEREAS, the creation of the GAD M&E Team would further strengthen the M&E System for gender-responsive programs, projects and activities and to assess the progress of GAD-related programs, projects and activities;

WHEREAS, the recent local election requires the reestablishing the Gender and Development Monitoring and Evaluation Team due to the end of term of other members;

NOW, THEREFORE, I, FREDDIE D. DOMINGO, Municipal Mayor of Pura, Tarlac, by the virtue of the powers vested in me by law, do hereby order:

Section 1. Composition of the GAD M&E Team. The GAD M&E Team shall be composed of:

Adelaida Calura, Women’s Rural Improvement Club President


Section 2. Functions. The GAD M&E Team shall:

- a. Monitor the implementation of GAD – related programs, projects and activities in their respective offices and suggest corrective measures to improve implementation of GAD PPAs and GFPS activities;
- b. Prepare and consolidate agency GAD accomplishment and evaluation reports; and
- c. Submit GAD Evaluation Report to the DILG Regional Office at the end of the Local Chief Executive’s three-year term.

Section 3. Meetings. The GAD M&E Team shall meet quarterly, or as often as may be necessary.

Section 4. Effectivity. This Executive Order takes effect immediately.
